This book focuses on José Martí's reflections and critique of social, cultural, and political events in the United States between the years of 1880 and 1895, bringing together some of the most recognized scholars from the United States, Cuba, South America, and Europe studying Martí in a unique contribution and collaborative international effort.

Alfonso Reyes (1889-1959) was the embodiment of the Latin American poet, essayist, and literary theorist during the first half of the twentieth century. With an astonishing intellectual curiosity and capacity for work, he thought and wrote about every important topic and major intellectual current that defined his beleaguered times. This collection recovers Reyes' legacy from the standpoint of the twenty-first century, with essays written exclusively for this book by scholars from Colombia, Croatia, Cuba, France, Mexico, and the United States. They analyze Reyes' poetry and essays from contrasting theoretical approaches and innovative readings of his major poetic works; his philosophical correspondence with leading European and Mexican writers; modernism in the Anglo-American and Latin American essay tradition; and, among other topics of interest, the idea of America and cosmopolitanism in his essays. The volume includes a full-length introduction, an interview with Latin American poet and essayist Octavio Armand, and English translations of Armand's poems. The study is of significant value to scholars, teachers, students, and the general reader interested in a seminal writer who shaped the writing of poetry and the essay in Latin American letters during the first half of the twentieth century.

This study finds in Oliver Goldsmith's early work a compelling narrative of social protest and professional accommodation: the struggle of an anonymous "hack" with expectations of recognition and fame too unrealistic for survival in a newly forming profession. As "true critic," as "foreign correspondent" to the magazines, and as an anonymous voice of protest against the com-

mercialization of letters, Goldsmith defined a journalistic self that would inform his later productions. Goldsmith was the "true critic" assailing the romance of - and proclaiming aesthetic standards for - poetry, philosophy, history, satire, and most of the staples of the press in the late 1750s and early 1760s. He was the "foreign correspondent" who, without leaving his bookseller's garret, gave a "first-hand" account of the latest in fashion and learning throughout Europe. He was the blistering social critic attacking the taste of booksellers and "coffee-house readers." And, perhaps most significantly, he provided a lens through which to view the commercialization and professionalization of the publishing industry at a time when literary patronage was moribund. He was, in fact, one of the most important commentators on a period of war and economic expansion, rapid change in public taste, and revolutionary developments in the press. Indeed, the journalistic achievements of Oliver Goldsmith invite a reconsideration of the man doomed for so many years to play "Doctor Minor" to Johnson's "Doctor Major." Long before he established a reputation as the author of *The Vicar of Wakefield*, *She Stoops to Conquer*, and *The Deserted Village*, Goldsmith was establishing his unique journalistic voice - a voice incredibly diverse, if also frequently self-contradictory. There is no doubt that Goldsmith was something of a controversial figure - working for both of London's monthly book review journals while they were engaged in an ongoing, venomous, and well-publicized dispute. But it is important to remember that he was respected, too. He did serve, after all, as principal contributor to several of London's most successful newspapers and magazine miscellanies. In this capacity, his career intersected with the careers of Arthur Murphy, John Newbery, David Hume, Thomas Gray, Edmund Burke, and the most prominent booksellers, authors, and editors of the period. As interest in eighteenth-century English journalism continues to accelerate, the critical reputation of Oliver Goldsmith which has been dwindling for years may receive an important boost. Scholars now have a wealth of primary and critical material from which to construct a contextual framework for understanding literary, social, and political developments in eighteenth-century England. Perhaps this wealth of information will lead them to reassess the man who not only exemplified, but also consistently commented on, the state of the press in "High Georgian" England.

Latin American women have long written essays on topics ranging from gender identity and the female experience to social injustice, political oppression, lack of educational opportunities, and the need for female solidarity in a patriarchal environment. But this rich vein of writing has often been ignored and is rarely studied. This volume of twenty-one original studies by noted experts in Latin American literature seeks to recover and celebrate the accomplishments of Latin American women essayists. Taking a variety of critical approaches, the authors look at the way women writers have interpreted the essay genre, molded it to their expression, and created an intellectual tradition of their own. Some of the writers they treat are Flora Tristan, Gertrudis Gómez de Avellaneda, Clorinda Matto de Turner, Victoria Ocampo, Alfonsina Storni, Rosario Ferré, Christina Peri Rossi, and Elena Poniatowska. Writing is crucial to anthropology, but which genres are anthropologists expected to master in the 21st century? This book explores how anthropological writing shapes the intellectual content of the

discipline and academic careers. First, chapters identify the different writing genres and contexts anthropologists actually engage with. Second, this book argues for the usefulness and necessity of taking seriously the idea of writing as a craft and of writing across and within genres in new ways. Although academic writing is an anthropologist's primary genre, they also write in many others, from drafting administrative texts and filing reports to composing ethnographically inspired journalism and fiction.

As a textual form, the *essai* predominates in modern and contemporary literature in French. Emerging from an earlier tradition and distinguished from its English-language counterpart, the French-language essay ranges from Stéphane Mallarmé to Colette, Victor Segalen to Aimé Césaire, Jean Grenier to Pierre Michon. The *essai* remains, however, one of the most hazily identified of textual forms, its definition often depending on the progressive elimination of all other generic possibilities. Excluded from the archigenres (theatre, poetry, *récit*), it can even be seen as a hold-all category whose role is to absorb the anarchic extremes of writing. It is perhaps this very lack of pretension to orthodoxy that has drawn so many writers to the *essai*. The conventional understanding of the term - as a tentative, unsystematic exploration - stresses the genre's provisional nature, its refusal of any claims to comprehensiveness. The *essai* exploits the devices of anecdote, illustration and humour; it is addressed to a wide and often general audience; it is also intricately linked to the performance of ideological and writerly strategies, often reordering the classical art of rhetoric and persuasion. As the contributions to this volume show, there is a need to outline an ethics and politics, as well as poetics, of essayism.

An encounter between philosophy and journalism recurs across the modern philosophical tradition. Images of reporters and newspaper readers, messengers and town criers, announcements and rumors populate the work of such thinkers as Kierkegaard, Nietzsche, and Benjamin. This book argues that these three thinkers' preoccupation with journalism cannot be separated from their philosophy "proper" but plays a pivotal role in their philosophical work, where it marks an important nexus between their theories of history, time, and language. Journalism, in the tradition Van deputte brings to light, figures before anything else as a cipher of the time in which philosophy is written. If the journalist and newspaper reader characterize what Kierkegaard calls "the present age," that is because they exemplify a present marked by the crisis of the philosophy of history—a time after the demise of history as a philosophizable concept. In different ways, the pages of the newspaper appear in the European philosophical tradition as a site where teleological and totalizing representations of history must founder, together with the conceptions of progress and development that sustain them. But journalism does not simply mark the end of philosophy; for Kierkegaard, Nietzsche, and Benjamin, journalistic writing also takes on an exemplary role in the attempt to think time and history in the wake of this demise. The concepts around which these attempts crystallize—Kierkegaard's "instant," Nietzsche's "untimeliness," and Benjamin's "actuality"—all emerge from the philosophical confrontation with journalism and its characteristic temporalities.

Redressing a gap in Chartism studies, Rob Breton focuses on the fiction that emerged from the movement, placing it in the context of the Victorian novel and reading it against the works aimed at the middle-class. Breton examines works by well-known writers such as Ernest Jones and Thomas Cooper alongside those of obscure or anonymous writers, rejecting the charge that Chartist fiction fails aesthetically, politically, and culturally. Rather, Breton suggests, it constitutes a type of anti-fiction in which the expectations of narrative are revealed as irreconcilable to the real world.

Taking up a range of genres, including the historical romance and social-problem story, Breton theorizes the emergence of the fiction against Marxist conceptualizations of cultural hegemony. In situating Chartist fiction in periodical print culture and specific historical moments, this book shows the ways in which it serves as a critique of mainstream Victorian fiction.
