This self-contained reference/text presents a thorough account of the theory of real function algebras. Employing the intrinsic approach, avoiding the complexification technique, and generalizing the theory of complex function algebras, this single-source volume includes: an introduction to real Banach algebras; various generalizations of the Stone-Weierstrass theorem; Gleason parts; Choquet and Shilov boundaries; isometries of real function algebras; extensive references; and a detailed bibliography.;Real Function Algebras offers results of independent interest such as: topological conditions for the commutativity of a real or complex Banach algebra; Ransford's short elementary proof of the Bishop-Stone-Weierstrass theorem; the implication of the analyticity or antianalyticity of f from the harmonicity of $\operatorname{Re} f$, $\operatorname{Re} f(2)$, $\operatorname{Re} f(3)$, and $\operatorname{Re} f(4)$; and the positivity of the real part of a linear functional on a subspace of $C(X)$.;With over 600 display equations, this reference is for mathematical analysts; pure, applied, and industrial mathematicians; and theoretical physicists; and a text for courses in Banach algebras and function algebras.

Though it incorporates much new material, this new edition preserves the general character of the book in providing a collection of solutions of the equations of diffusion and describing how these solutions may be obtained.

This book provides a primary resource in basic fixed-point theorems due to Banach, Brouwer, Schauder and Tarski and their applications. Key topics covered include Sharkovsky's theorem on periodic points, Thron's results on the convergence of certain real iterates, Shield's common fixed theorem for a commuting family of analytic functions and Bergweiler's existence theorem on fixed points of the composition of certain meromorphic functions with transcendental entire functions. Generalizations of Tarski's theorem by Merrifield and Stein and Abian's proof of the equivalence of Bourbaki-Zermelo fixed-point theorem and the Axiom of Choice are described in the setting of posets. A de-

tailed treatment of Ward's theory of partially ordered topological spaces culminates in Sherrer fixed-point theorem. It elaborates Manka's proof of the fixed-point property of arcwise connected hereditarily unicoherent continua, based on the connection he observed between set theory and fixed-point theory via a certain partial order. Contraction principle is provided with two proofs: one due to Palais and the other due to Barranga. Applications of the contraction principle include the proofs of algebraic Weierstrass preparation theorem, a Cauchy-Kowalevsky theorem for partial differential equations and the central limit theorem. It also provides a proof of the converse of the contraction principle due to Jachymski, a proof of fixed point theorem for continuous generalized contractions, a proof of Browder-Gohde-Kirk fixed point theorem, a proof of Stalling's generalization of Brouwer's theorem, examine Caristi's fixed point theorem, and highlights Kakutani's theorems on common fixed points and their applications.

This introductory text covers the algebra of subsets and of rings and fields of sets, complementation and ideal theory in the distributive lattice, closure function, neighborhood topology, much more. Includes numerous exercises. 1960 edition.

This volume is the outcome of a seminar on the history of mathematics held at the Chennai Mathematical Institute during January-February 2008 and contains articles based on the talks of distinguished scholars both from the West and from India. The topics covered include: (1) geometry in the *oulvasatras*; (2) the origins of zero (which can be traced to ideas of *lopa* in Paoini's grammar); (3) combinatorial methods in Indian music (which were developed in the context of prosody and subsequently applied to the study of tonal and rhythmic patterns in music); (4) a cross-cultural view of the development of negative numbers (from Brahmagupta (c. 628 CE) to John Wallis (1685 CE)); (5) *Kunnaka*, *Bhavana* and *Cakravala* (the techniques developed by Indian mathematicians for the solution of indeterminate equations); (6) the development of calculus in India (covering the millennium-long history of discoveries culminating in the work of the Kerala school giving a complete analysis of the basic calculus of polynomial and trigonometrical functions); (7) recursive methods in Indian mathematics (going back to Paoini's grammar and culminating in the recursive proofs found in the Malayalam text *Yuktibhaua* (1530 CE)); and (8) planetary and lunar models developed by the Kerala School of Astronomy. The articles in this volume cover a substantial portion of the history of Indian mathematics and astronomy. This book will serve the dual purpose of bringing to the international community a better perspective of the mathematical heritage of India and conveying the message

that much work remains to be done, namely the study of many unexplored manuscripts still available in libraries in India and abroad.
